- All non-compliant returns will not be accepted after 14 days from the receipt of the goods.
- The paper request, completed in its entirety, must be sent with this document to our office via email at info@foresteel.eu.
- The request must contain the complete references of the returned item extracted from our sales document (Transport document number, document date, type of defect found).
- Upon receipt of the goods, our technicians will check the conditions of the returned material. In the event if the goods have a defect under warranty, we will repair or replace it as soon as possible.
- If the goods present problems related to wear, tampering or improper use of the same, a cost estimate will be made for the repair and transport costs, which will be charged to the customer.
- After the appropriate checks and following the acceptance of the request, FS Production OÜ issues the return authorization, marked with a progressive number.
- All returns must be sent to free of charge to FS Production OÜ, unless otherwise specified, attaching a copy of the return authorization. Returns without this document, fully completed and authorized by FS Production OÜ, will not be accepted.
- FS Production OÜ invites you to check the packages delivered by the courier and in the event of damage to the packages, it is advisable to accept the goods with reserve.
- FS Production OÜ carries out quality checks on goods before they are sent; therefore, items that are damaged during transport are not covered by the warranty conditions and are subject to transport insurance.
- Warranty returns without a description of the defect will not be accepted.
